- 7. <u>Bidders shall have to quote for complete Central Cold Depot for Vaccine Storage mentioned in the Schedule of requirements and delivery & installation should be at Institute of Veterinary Biologicals, Khanapara, Guwahati-781022.</u>
- 8. Bidder offering right price for quality goods shall be encouraged.
- 9. Available Brochures/ Booklet /leaflet etc. have to be submitted for evaluation.

Bid Validity:

10. The Bid submitted by the bidder shall be valid for a period of 180 (hundred eighty) days from the specified date of opening of bids or beyond any period of extension subsequently requested by the purchaser **Bids not conforming to this provision shall be treated as non-responsive.**

Bid Security (Earnest Money):

- 11. The Bidder shall enclose a bid security of 2% (for SC, ST & OBC, it is 1%) for Schedule of items on offered rate in the form of a duly pledged Bank Draft/NSC/Banker's Cheque in favour of Joint Director, Institute of Veterinary Biologicals, Animal Husbandry & Veterinary Department, Assam, Guwahati-22. The purchaser shall outright to reject the Bids that not accompanied by the aforesaid requisite amount of bid security.
- 12. The bid security will be released immediately upon submission of the performance security and signing of contract agreement by the purchaser with the successful (qualified) bidder.

- 13. Bidder shall furnish the Bid security for aggregate contract price they offered.
- **14.** The successful Bidder shall furnish performance security @5% of the quoted contract price in the form of Bank Draft / bank Guarantee in favour of the Joint Director, Institute of Veterinary Biologicals, A.H. & Veterinary Department, Khanapara, Guwahati-781022.

Delivery Period:

15. Supply and installation of Central Cold Depot for vaccine storage should be completed strictly within 21 (twenty one) days from the date of receipt of supply order from the purchaser. The Central Cold Depot for Vaccine Storage shall have to be supplied, installed & commissioned within the stipulated delivery period as mentioned above, otherwise Penalty @ Rs.0.005% per day upon the value of the supply order shall be imposed in case of failure to deliver the item and shall be calculated from the last date of delivery time. Quotations not conforming to this provision shall be rejected at the discretion of the purchaser.

Place of Delivery (installation, if applicable):

16. The <u>Central Cold Depot for Vaccine Storage</u> shall be delivered (duly installed & commissioned,) to the consignees at **Institute of Veterinary Biologicals, Khanapara, Guwahati-22.** Articles have to be supplied to the consignee at the cost of bidder.

Bid Price (Quoted Contract Price)

- 17. To facilitate prompt evaluation, bidder shall quote price strictly as per the "Format of Quotation-II" for Schedule of requirements along with technical brochure for the offered item. Incomplete bid shall be treated as non-responsive, at the discretion of the purchaser.
- 18. The bidder has to put the price for complete <u>Central Cold Depot for Vaccine Storage</u> as mentioned in the schedule of requirements.
- **19.** There should not be any overwriting. Correction(s) if any shall be made by crossing out, initialing, dating and re-writing.
- 20. Bidders shall quote rates for total quantities of items as in the schedule of requirements and the contract price must be quoted excluding taxes. The final Rate evaluation will be on the basis of quoted Rate excluding GST and any other tax etc. Quotations from Bidders quoting rates in lots shall be rejected at the discretion of the purchaser.
- **21.** All duties and other levies paid or payable by the bidder under the contract shall be included in the total Bid price. These will, however, not be considered for the purpose of evaluation of the bids.
- 22. The prices payable to the supplier, except taxes, duties and levies, as shall be stated in the contract shall be fixed & firm and not subject to adjustment/variation during the performance of the contract.
- 23. The contract price quoted by the bidder shall include transportation, delivery, and other incidental charges at final destinations including installation & commissioning.
- **24.** Wherever the laws and regulations require deduction of taxes at the source of payment of purchaser shall effect such deduction from the payment due to the supplier, the remittance of amounts so deducted and issuance certificate for such deductions shall be made by the purchaser as per the laws and regulations in force.
- 25. The prices should be quoted in Indian Rupees only.

Warranty:

26. The warranty of the <u>Central Cold Depot for Vaccine Storage</u> shall be as per the <u>prevailing warranty/guaranty policy/certificate of the manufacturer for the item</u>. The bidder shall furnish the warranty period for the items in the bid that shall be criteria for evaluation of the bid. The warranty certificate shall be duly signed to hand over to the consignee at the time of delivery of the articles. Minimum 24 months onsite warranty with original spare parts shall be criteria for evaluation of the bid.

Immediately after the end of warranty period comprehensive **Annual Maintenance Contract** (atleast for three years) facility should be available.

27. If the supplier have been notified and fails to replace the defected goods within 7(seven) days, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.

Quality testing of goods:

28. Company's quality testing certificate for the compressor, condenser, cooling unit etc should be attached with the bills for payment.

Evaluation, Inspection & Test of the goods:

29. The purchaser or his nominated **Technical/checking committee** shall inspect/test the items along with *specification and brochures/ booklet /leaflet etc.* of the bidder for evaluation.

Opening and evaluation:

30. The quotations shall be **received up to 14.00 hours (IST) on 07-01-2019** and shall be opened **at 14.30 hours (IST) on the same day** in the office of the Joint Director, Institute of Veterinary Biologicals, A. H. & Veterinary Department, Assam, Guwahati-22. The bidders or his authorized representatives may attend at the time of bid opening.

Whereas the Bid of requirements shall be opened on the date and time scheduled for Bid opening and read out in public prima facia (unevaluated).

- **31**. In the event of the specified date for the submission of bids **being declared a holiday** for the purchaser, the bids will be received up to the appointed time **on the next working day** and will be opened at the appointed time and location on the same day.
- **32.** The purchaser shall evaluate and compare the Bids determined to be substantially responsive i.e., which are:
 - a. "Format of Quotation II" for schedule of requirements duly signed and sealed (stamped).
 - b. Signed copy of Bidding Document and relevant documents as per qualification criteria.
 - c. Satisfy the Qualification Criteria.
- **33.** The purchaser at his discretion **may call for any clarification(s)** /**document(s)** from any or all the bidders during the process of evaluation of Bids with short notice.

Qualification Criteria:

34. The Bidder should enclose the following with their Bids:

- a. The bidder must be a manufacturer or authorized agent/dealer/supplier of a reputed manufacturer of the goods.
- b. Manufacturer Authorization Certificate should be furnished in the prescribed **format-III**, provided along with the bidding document.
- c. Bidder should follow the specification criteria strictly.
- d. PAN No. with document.
- **35**. In case of manufacturer the following document to be submitted:
 - a. Copy of manufacturing license from the proper authority.
 - b. Certificate of quality control, to be furnished wherever applicable.
 - c. PAN No. with document.
 - d. Technical brochure

Award of Contract:

36. The purchaser shall award the contract prior to expiry of the bid validity period, to the bidder whose quotation/bid has been determined to be substantially responsive and who has offered the lowest quoted price subject to quality of the goods as per clause 7 to 9.

Other:

- **37.** The Purchaser reserves the right to accept or reject any quotation/bid and to cancel the instant bidding process and reject all bids/quotations at any time prior to award of contract without thereby incurring any liability to the affected bidder or bidders or any obligation to inform the affected bidder or bidders of the grounds for the purchaser's action.
- 38. Each bidder shall submit only one quotation/bid.
- **39.** The decision of the Director, A. H. & Veterinary Department, Assam shall be final in case of any dispute.
- **40**. **The Particulars of Notice No. (NIQ No.) of the "Invitation of bids"** should be indicated in bold letters on the top of the sealed envelope.

Payment:

- **41.** Payment for the items shall be made as follows:
 - a. The bills to be submitted to the consignee to sign challan and to certify the bill after verification/inspection of the supplied goods and showing the stock book entry of the articles by the consignee to make necessary payment by the Director. All payments shall be made in INDIAN RUPEES only.
 - **b.** Wherever the laws and regulations require deduction of taxes at the source of payment.
